The Government of the Democratic Republic of S. Tomé and Príncipe *has received* financing from the World Bank toward the cost of the **Projeto de Investimento em Resiliência das Áreas Costeiras da África Ocidental-WACA**, and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include:

1. Fazer o Levantamento de todas a leis RELEVANTES do país relacionadas com propriedade e títulos de terras com realce para o Quadro de Políticas de Reassentamento nas comunidades costeiras vulneráveis de São Tomé e Príncipe;
2. Elaborar a regulamentação para o usufruto das habitações e os respetivos talhões de terreno para os beneficiários das casas sociais construídas no âmbito do projeto;
3. Elaborar a regulamentação para disciplinar a utilização das zonas de riscos que irão ficar livres com a transferência voluntaria da população para as novas habitações nas zonas seguras,
4. Elaborar um quadro jurídico que reforce a proteção de áreas de riscos a serem desocupadas com reassentamento voluntário de modo a evitar que a mesma seja reocupada para construção de novas habitações.
5. Elaborar um plano de utilização das áreas de risco a serem desocupadas tomando em conta a sua transformação em zonas de utilidade pública, cujos investimentos a serem feitos, deverão ser regulamentados neste pacote legislativo e regulamentar.

The Project Implementation Agency (Agência Fiduciária de Administração de Projetos AFAP) invites eligible consulting firms (“Consultants”) to express their interest in providing such services. Interested consultants must provide information that demonstrates that they have the required qualifications and relevant experience to perform the services by sending a Letter of Intent, CV and supporting documents (execution of similar contracts, experience of similar work in the region, etc.). The shortlisting criteria are: *a) core business and years in business, b) relevant experience, c) technical and managerial capability of the firm*. Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers” July 2016, revised in October 2017, August 2018 and November 2020 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the **Consultant’s qualifications-based selection** method set out in the Procurement Regulations.
